- The Sean Patrick Maloney-led DCCC has a record of spending hundreds of thousands of dollars on private jets, foreign travel, new office furniture, and flowers.
 - One Democratic staffer described Maloney as “high-maintenance,” and questioned if he wanted to win races or have nice things.
