

 - The statement denounced "systemic racism" and "senseless and cruel [police] killings." "Since the beginning of the COVID-19 pandemic, we have witnessed its


disproportionate impact on Black and Brown communities, as generations of compounded health disparities, discrimination, and systemic racism have been exposed. On May 25, 2020, we lost another Black life in America with the untimely death of George Floyd at the hands of police officers from the Minneapolis Police Department. His death has sparked a national uproar in response.
