<p>Recommendation: Approve agreement between The Confucius Institute Headquarters and Cedarlane Middle School to establish a Confucius Classroom at Cedarlane Middle School.</p> <p>Analysis: The Confucius Classroom at Cedarlane Middle School shall be a non-profit institution with the purpose of enhancing understanding and friendship between the young people of China and the United States by sponsoring courses of Chinese language and culture. The Confucius Classroom at Cedarlane Middle School can serve the following Chinese teaching programs: - Teach Chinese and sponsor cultural activities and Chinese competitions; - Train teachers to teach Chinese in primary and middle schools; - Organize summer and winter camps in China for secondary school students; and - Compile teaching materials. The Confucius Classroom shall have a Board of Advisors. The Board of Advisors shall have the responsibility to provide input for the Confucius Classroom. The make-up of the Advisory Board will include two parents, two teachers, the Principal and Vice-Principal of Cedarlane Middle School. The Confucius Institute will: - Provide necessary start-up funds and equipments for teaching and cultural activities, and provide a set amount of annual funds according to needs; - Provide 1,000 volumes of books, audio-visual, multimedia materials and courseware, and to authorize the use of on-line courses; and - Send Chinese instructors or volunteers according to need and pay for their air fares and salaries.
