

There is a crime wave going through Colorado and Brittany Pettersen's dangerous, pro-criminal voting record lets criminals off the hook. Pettersen voted to reduce sentencing on some murderers, getting them released from prison sooner.

**There's a crime wave going through Colorado and the statewide murder rate increased by 47% between 2019 and 2021:**

- **Between 2019 and 2021, violent crime rose by 17% in Colorado and murders rose by 47% statewide.** "Violent crime, which counts homicides, aggravated assaults, sex assaults and robberies, is up 17 percent between 2019 and 2021. - **Over the same period, property crime in Colorado went up by 20% and auto theft rose by 86%.** Property crime is up 20 percent and auto theft is up 86 percent between 2019 and 2021, according to the Colorado Bureau of Investigation." **In 2021, Pettersen voted for SB21-124 – a bill that reduced the penalties for some felony murders:**

- **On March 31, 2021, Brittany Pettersen voted for SB21-124.** (Colorado General Assembly, SB21-124, Third Reading: Passed 22-13, [Pettersen Voted Aye](#), 3/31/21)
- **SB21-124 reclassifies and reduces the penalties for murders that occur during a separate felony and specifies that the death must be caused by one of the felony's participants.** "Under current law, it is a class 1 felony as it pertains to first degree murder if a person commits or attempts to commit certain specified felonies and the death of a person, other than one of the participants, is caused by anyone during the crime. The act changes the current law by: Moving the crime from first degree murder to second degree murder and changing the penalty from a class 1 felony to a class 2 felony that is subject to crime of violence sentencing; Requiring the death be caused by a participant; and Repealing certain elements of the affirmative defense." - **Penalties for those murders, "felony murder," are now similar to a second-degree murder charge – 16 to 48 years in prison.** "Senate Bill 124: People convicted of felony murder in Colorado would no longer be sentenced to life in prison without the possibility of parole. Instead, they'd face 16 to 48 years in prison, a sentence similar to a second-degree murder conviction."
