A FAQ released by Rep. Ocasio-Cortez’s office admits that no amount of taxation would be able to pay for the Green New Deal:

- **Rep. Ocasio-Cortez’s office released a FAQ on the Green New Deal as part of its rollout.** “Ocasio-Cortez’s office sent a copy of the resolution this week as well as an embargoed FAQ sheet about the initiative to various media outlets, including The Hill. - **The FAQ admits that even if every billionaire and corporation poured all of their resources into funding the Green New Deal, it still would not be sufficient.** “The level of investment required is massive. Even if every billionaire and company came together and were willing to pour all the resources at their disposal into this investment, the aggregate value of the investments they could make would not be sufficient. 
- **The FAQ explained the need to “get rid of farting cows” in order to reach net-zero emissions.** “We set a goal to get to net-zero, rather than zero emissions, in 10 years because we aren’t sure that we’ll be able to fully get rid of farting cows and airplanes that fast, but we think we can ramp up renewable manufacturing and power production, retrofit every building in America, build the smart grid, overhaul transportation and agriculture, plant lots of trees and restore our ecosystem to get to net-zero.” (Green New Deal, [Frequently Asked Questions](#), 2/7/19)

The Green New Deal could “lead to mass closures of small farms” and devastate the dairy industry in the area:

- **According to economist William Nordhaus, polluters would have to pay \$230 per metric ton of carbon dioxide, which is about \$2,000 per cow.** “Fortunately, environmentalists have provided us with an estimate of just what it should cost polluters to prevent global

warming. Economist William Nordhaus estimated that polluters should have to pay \$230 per metric ton of carbon dioxide (CO2) emissions in order to remain below 2.5 degrees Celsius of warming. This works out to about \$2,000 per year per cow.” (Daniel Turner and Ken Lassman, “What the Green New Deal Could Cost a Typical Household,” CEL.org, 02/26/20)

- **These additional costs could lead to mass closures of small farms in an industry already struggling, according to a study by the Competitive Enterprise Institute and Power The Future.** “Some of this might be borne by consumers, but it is likely that consumers would seek milk alternatives as the price of milk shot up. Indeed, consumers are already moving away from milk at a time of low prices.
