

Carl Marlinga served as a character witness for a political ally who was found guilty and sent to prison for raping a 26 year old woman. Two of Marlinga's political allies, Eric Smith and Anthony Marrocco, are now facing potential federal prison sentences in connection with corruption scandals.

Carl Marlinga testified as a character witness in a rape trial for his political ally, William Hackel, who was found guilty and sent to prison for raping a woman who was 26 years old – less than half Hackel's age:

- In 1999, Macomb County Sheriff William Hackel was charged with raping a woman in a hotel while he was attending the Michigan Sheriffs' Association fall conference. The former prosecutor is still facing the following charges: 1 count official misconduct in office, a five-year felony; 1 count tampering with evidence in a civil proceeding, a four-year felony; 1 count accessory after the fact to Liston's embezzlement by a public official, a five-year felony; 1 count conducting a criminal enterprise, a 20-year felony; 5 counts embezzlement by a public official, a 10-year felony ~ one count each for years 2014, 2015, 2016, 2017 and 2018; and 1 count of conspiracy to commit forgery, a 14-year felony and a \$10,000 additional fine."
