- Property taxes in Mecklenburg County go towards the funding of public services, such as schools and police and fire departments. “When you call the police or fire department, play in the park, send your children to public school, check out a book at the library, or eat at an inspected restaurant, you are using services paid for by your property taxes. Your taxes also pay for services to help people move from welfare to work, protect children and senior citizens from abuse and neglect, protect our water and air from pollution, repair and build roads, and much more.
