

Despite voting for trillions in new taxes for working Americans, Marcy Kaptur couldn't be bothered to pay her own taxes, failing to pay property taxes on nine separate occasions.

Marcy Kaptur has voted for trillions in new taxes:

- **Marcy Kaptur voted for the Inflation Reduction Act.** (H.R. 5376, [Roll Call 420](#), Passed 220 – 207, R 0-207, D 220-0, Kaptur voted Yea, 8/12/22)
 - **The Congressional Budget Office estimates that the Inflation Reduction Act would cost those making less than \$400,000 an estimated \$20 billion more in taxes over the next 10 years.** “An analysis by the CBO estimates those earning less than \$400,000 – the group on which Biden promised not to raise taxes – will pay an estimated \$20 billion more in taxes over the next decade as a result of the Democrat-pushed \$740 billion package, which also sets aside \$80 billion to hire 87,000 IRS agents.” (Lydia Moynihan, “Inflation Reduction Act will cost middle class \$20B in new taxes: CBO,” [New York Post](#), 8/15/22)
- **On October 4, 2017, Kaptur voted for a Progressive Caucus budget plan that included \$8.2 trillion in tax hikes for corporations and some individuals.** “Grijalva, D-Ariz., for Pocan, D-Wis., substitute amendment that would provide for \$3.8 trillion in new budget authority in fiscal 2018, not including off-budget accounts. It would raise overall spending by \$3.5 trillion over 10 years and would increase revenues by \$8.2 trillion over the same period through policies that would increase taxes for corporations and high-income individuals. It would repeal the Budget Control Act sequester and caps on discretionary spending, would modify the tax code by adding five higher marginal tax rates, would create a public insurance option to be sold within the current health insurance exchanges and would call for implementation of comprehensive immigration overhaul.” (H. - **On October 4, 2017, Kaptur voted for a Democrat budget plan that included tax hikes on high earners.** “Voting 156-268, the House on Oct. 5 defeated a Democratic alternative to H Con Res 71 that called for raising taxes on the wealthiest Americans, putting domestic and foreign-affairs spending on a par with military outlays, shoring up the social safety net and improving the Affordable Care Act. A yes vote was to adopt a Democratic budget that would result in an \$852 billion annual deficit in fiscal 2027. (“How Your U.S. Lawmaker Voted,” [Seattle Times](#), 10/7/17; H. Con. Marcy Kaptur has been late to pay her property taxes 9 times:

- **Lucas County Chief Deputy Treasurer Mark Austin confirmed Kaptur was late to pay her taxes nine times from 2007 to 2010.** “Miss Kaptur owns her house, two adjacent vacant parcels, an adjacent house, and a house a couple of blocks away. Mark Austin, chief deputy treasurer for Lucas County, confirmed that Miss Kaptur had late tax filings. He said she filed late nine times from 2007 to 2010. Only one bill was more than 11 days late, and she paid a total of \$295 in late penalties. ‘Our office treated the Congresswoman exactly as we would any other Lucas County resident. She paid the same late fees as everyone else, she never asked for nor received any preferential treatment...’ Mr. Austin said.” (Tom Troy, “PAC Targets Kaptur In Ads,” [Toledo Blade](#), 2/29/12)

- **In 2010, Kaptur was late paying taxes on three of her properties.**

“Congresswoman Marcy Kaptur paid her property taxes late for the most current due date. According to county auditor records, Kaptur paid her taxes for two properties she owns, but failed to pay at three others. The taxes were due in July of this year. Kaptur paid them in August.  - **According to her Congressional Office, Kaptur paid the taxes on time but the postmarked date was one business day late.** “The congresswoman's office explains when she returned from Washington late on the evening of Friday, July 30th she dropped the bill in a mailbox. However, the payment was not postmarked until Monday, August 2nd. That's one business day late. The county's website had not been fully updated to reflect the payment. That led to some incorrect information. Again, the treasurer's office tells 13abc that the property taxes were paid in full.” (“Update: Tax Bill From Rep. - **In 2012, The Campaign for Primary Accountability released an advertisement saying that Kaptur has been late on her Ohio taxes at least nine times.** “The Campaign for Primary Accountability is lending a helping hand to Rep. Dennis Kucinich in his primary by attacking Rep. Marcy Kaptur as delinquent on her Ohio property taxes. The Super PAC is up with a district-wide \$116,000 buy that accuses the Toledo-based congresswoman of being late on her Ohio property taxes nine times, while noting that taxes on her Washington, D.C. condo have been paid in full.” (David Catanese, “Super PAC Attacks Kaptur On Ohio Taxes,” [Politico](#), 2/28/12)

 - **A Lawyer Representing Kaptur Said The Advertisement Was “Absolutely False.”**

“The Houston-based conservative Campaign for Primary Accountability started airing one ad on TV stations in the district Monday and launched its second ad Wednesday. A lawyer representing Miss Kaptur sent a letter to television stations Wednesday calling the first ad ‘absolutely false’ and for it to be pulled from the air.” (Tom Troy, “PAC Targets Kaptur In Ads,” [Toledo Blade](#), 2/29/12)

- **In 2012, Kaptur’s campaign spokesman acknowledged some of the late payments.**

“Kaptur's campaign acknowledged that she has paid a total of \$295.20 in late fees on property taxes going back to 2006. Five instances involved three rental properties in her neighborhood. ‘She has always paid her taxes on her home and rental properties within 10 days of the due date except in one instance, when she was six weeks overdue and paid the penalty,’ spokesman Matthew Klempner said.” (Tom Feran, “Texas-Based PAC Says Marcy Kaptur Really Lives In A Fancy, Suburban-Washington Condo,” [Polifact](#), 3/2/12)
