## Porter Comparing Protestors to Jan. 6

Per a Vanity Fair profile from October 2021, Katie Porter dwelled on the “danger” she encountered at her town hall and said “This is the parallel for me between the town hall and January 6...Town halls and voting are the bread and butter of representative government, and both of those things in the last six months for me have been sites of violence”:

*Editor’s Note: A fight between protestors and Katie Porter supports erupted at her town hall. The protest was led by Nick Taurus who is running against Porter in midterm elections. It was her first in-person town hall since the start of the COVID-19 pandemic. For additional details about the event, please see [here](#).*

- Per a Vanity Fair profile from October of 2021, Porter’s “...presence in the tangle, alone, seemed to startle the bad actors into reconsidering their behavior...By the time they arrived, she had mostly de-escalated the tension.” “Porter made her way through the knot of people until she reached the center. She put each of her arms around two clearly rattled seniors; her immediate concern was protecting them, keeping both from being pushed over. Porter called for calm. Her sudden presence in the tangle, alone, seemed to startle the bad actors into reconsidering their behavior. A handful of police officers were about a football field’s length away.
