

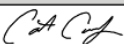
# STATEMENT

**In March 2025, It Was Reported That Conley's Campaign Launch Video, Labeled As Filmed In Ossining, NY, Was Actually Shot In Her Garage In Virginia.** "A Democrat running to replace Republican Rep. Mike Lawler in a district where she has never lived is making her plea to voters — from suburban Virginia. Democratic hopeful Cait Conley's campaign launch video was actually filmed in the garage of her Virginia residence, despite the fact that the words 'Ossining, NY' are overlaid on top of the video where she lifts weights and does pushups, Playbook reports. 'I'm ready to fight for New Yorkers,' Conley, a former Biden national security adviser and Army veteran, says in the clip. 'The video was filmed in the garage of Cait's old house in Virginia, where she lived while working at [Cybersecurity and Infrastructure Security Agency] protecting our nation's democracy and election security,' a campaign spokesperson texted Playbook. Fairfax County property records show Conley is still the owner of her 'old house.' Her campaign declined to say if someone else lives there now. **In January 2025, Conley Moved To Westchester County And Ran For Congress Despite Never Living In NY-17.** "A Biden national security adviser and U.S. Army veteran has moved to Westchester County and launched a run for Congress — even though she's never lived in the 17th Congressional District. Democrat Cait Conley announced her run for the suburban seat held by GOP Rep. Mike Lawler Monday. 'I fought for my country, fought to protect our democracy, and now I'm reading to fight for New Yorkers,' Conley said in a video. 'Let's f—ing go.' Conley grew up nearby in the Hudson Valley, splitting time between divorced parents in Ulster County, near Pine Bush — in NY-19 — and in Beacon and Fishkill in Dutchess County — in NY-18 — a campaign spokesperson told Playbook. She attended West Point and spent years moving around and serving overseas in the Army, before living in Virginia where she most recently led election security at the Cybersecurity and

Infrastructure Security Agency. She left in January and moved to Ossining in Westchester County, living in NY-17 for the first time.
