Trone Garriott Opposed The One Big Beautiful Bill Act, Which Would Reduce Taxes On Overtime Pay, Saving The Average Overtime Worker Between \$1,400 And \$1,750 Per Year

The One Big Beautiful Bill Act (OBBA) contains a provision that allows for a tax deduction for all qualified overtime pay. “(a) IN GENERAL.—There shall be allowed as a deduction an amount equal to the qualified overtime compensation received during the taxable year.” ([H.R.1](#), Introduced: 5/20/25)

The Tax Break Would Be Available To Almost All American Workers Who Work Overtime And Are Paid An Hourly Wage. “Under the sprawling domestic policy bill that Republicans pushed through the House and are preparing to steer through the Senate, the tax break would be limited. It would be available only to Americans who, under federal law, must be paid at a time-and-a-half rate for working any time exceeding 40 hours in a week. The Bill Requires The Department Of Health And Human Services To Verify The Immigration Or Citizenship Status Of Applicants For Public Assistance Programs Using The Federal Systematic Alien Verification For Entitlements (SAVE) Database. “PUBLIC ASSISTANCE PROGRAMS— ELIGIBILITY AND REPORTING Section 1. Section 239.6, subsection 1, paragraph a, subparagraph (4), Code 2026, is amended to read as follows: (4) Information maintained by the United States citizenship and immigration services of the United States department of homeland security, including but not limited to information accessible through the systematic alien verification for entitlements online service Sec. 2. Section 239.6, subsection 2, Code 2026, is amended by adding the following new paragraph: NEW PARAGRAPH g. The systematic alien verification for entitlements online service maintained by the United States citizenship and immigration services of the United States department of homeland security to verify immigration and United States citizenship information. Republican Iowa State Senator Scott Webster Said That The Bill Makes It Clear That Illegal Aliens Should Never Be Eligible To Receive Public Assistance Using Taxpayer Dollars. “Sen. Scott Webster, R-Bettendorf, said the legislation will strengthen existing integrity and verification measures enacted by lawmakers in 2023 and will align Iowa with current policies in the federal spending and tax policy package signed into law last July. ‘Senate File 2422 makes it clear that illegal aliens should never be eligible to receive public assistance using taxpayer dollars,’ Webster said.” (Maya Marchel Hoff, “Bills Require Immigration Status Checks For Aid, Voting”, [The Gazette](#), 2/26/26)

SF 2422 Requires Checking Immigration Status When Considering Eligibility For Public Assistance Programs. “Description Senate File 2422 modifies various public assistance programs under the Department of Health and Human Services (HHS). The Bill is effective upon enactment. Division I – Public Assistance Programs – Eligibility and Reporting Description Division I of the Bill requires the HHS to use the Systematic Alien Verification for Entitlements (SAVE) online service maintained by the U.S. Department of Homeland Security (DHS) to verify immigration and citizenship information when determining eligibility for public assistance programs.” (SF 2422, Fiscal Note, [Iowa Legislative Services Agency, 2/25/26](#))

According To IA State Law, “Public Assistance’ Means The Supplemental Nutrition Assistance Program Or SNAP, The Medicaid Program Or Medicaid As Defined In Section 249A.2, The Family Investment Program Or FIP As Defined In Section 239B.1, And The Children’s Health Insurance Program Or CHIP.” (Chapter 239.1, [Iowa Code 2026, 12/9/25](#))

239.1 Definitions.

As used in [this chapter](#), unless the context otherwise requires:

1. “Applicant” means an individual who is applying for public assistance benefits in the state.
2. “Asset” for the purposes of the asset test for the supplemental nutrition assistance program under [section 239.4](#) means all of the following resources countable toward the maximum allowed household asset limit of fifteen thousand dollars:
 - a. All liquid resources.
 - b. All other personal property excluding one vehicle and the fair market value in excess of ten thousand dollars of an additional vehicle.
3. “Asset test” for the purposes of the asset test for the supplemental nutrition assistance program under [section 239.4](#) means the comparison of the collective value of all countable assets of the members of the applicant’s household to the maximum allowed household asset limit of fifteen thousand dollars.
4. “Department” means the department of health and human services.
5. “Public assistance” means the supplemental nutrition assistance program or SNAP, the Medicaid program or Medicaid as defined in [section 249A.2](#), the family investment program or FIP as defined in [section 239B.1](#), and the children’s health insurance program or CHIP.

The Iowa Medicaid State Plan Includes Funding From The Federal Government. “Iowa Medicaid State Plan What is a State Plan? A State Plan is an agreement between a state and the federal government that explains how the state runs its Medicaid program. It shows that the state follows federal rules and allows it to receive federal funding for Medicaid services. The Des Moines Register Reported On The Slate Of Bills Which Would Require Using A Federal “Systematic Alien Verification For Entitlements “Database To Check Whether Someone Qualifies For Benefits Programs Such As Food Assistance Or Medicaid. “A slate of bills moving through the Iowa Legislature would require using a federal database to check someone’s citizenship when they register to vote or apply for a driver’s license, a job or public assistance.
