In June 2022, Poindexter Voted To Opt Out Of An Ohio Law Allowing Fireworks To Be Discharged On Private Property On Certain Days During The Year, Keeping The City's Ban On Fireworks In Place. "Brook Park has opted out of an Ohio law that as of July 1 allows fireworks to be discharged on private property on certain days during the year. Ohio Substitute House Bill 172 provides an option for home rule cities such as Brook Park to impose a complete ban on the use of consumer-grade fireworks. Brook Park has banned fireworks for many years and will continue to do so. City Council passed an ordinance at its June 7 meeting reaffirming the Brook Park ban. Members suspended the second and third readings of the legislation to adopt it ahead of the state law's July 1 effective date. 'The city desires to continue to regulate the possession, sale, discharge, ignition and/or explosion of fireworks and desires to enact regulations to preserve residents' quiet enjoyment of their residential properties and ensure the safety of dense residential and business areas,' the Brook Park ordinance says.
