Moskowitz Founded MOD LLC, A Consulting Firm Named After His “Master Of Disaster” Nickname. “Moskowitz's important role — which later moved into dealing with the 2020 COVID-19 pandemic — earned him the affectionate nickname in local Florida papers as the "Master of Disaster." When he left the administration, he formed his own consulting company, MOD LLC, a reference to the moniker. The company quickly earned \$4 million, a congressional ethics disclosure revealed. Clients that required public disclosure, like Miami-Dade County, were revealed, but others were only referenced as ‘confidential clients not reported.’ ... In a statement to Rolling Stone, Moskowitz's office said that he was a consultant at the time and ‘has complied with all congressional ethics requirements.’” (Sarah K.
